Notes & Actions from Previous Meeting:

Security Company now employed to cover the additional security needs over the Christmas busy periods,

City Centre Ranger has had a very good response from businesses and the public for his role and presence.

Business Awards are to be distributed to the businesses between 26/12 - 31/12 with the overall best voted business of 2021 to be announced January 1st 2022

Item 1: Christmas Lights

The Board discussed the email sent from Cllr Owen Hurcum regarding the decision to end the agreement.

Reasonings behind ending the agreement was a unilateral decision based upon several reasons.

The City Council were deceitful from the beginning with 7.5k each was proposed in principle for the project and when discussed, we were told that the project came to £15k in total. Later we had a meeting with the festive lighting to only then discover that the xmas lights were only costing 7.5k.

BCC had signed the agreement prior to the board agreeing on the project,

The project was meant to cover areas from the bottom of the high street (skerries) through to the kyffin area, going up past the train station and through Upper Bangor. However, BCC found it only necessary for them to cover one section of the high street (Williams & Goodwin to So Chic) and for Bangor First to complete the other areas.

Item 3: High St WiFi

Menter Mon are currently working on a project to bring free public WiFi to the high street.
